Note: This carton contains a mixture of bound records, travel ephemera, and loose papers. The bound records often do not have any clear identification of original owner and will require a significantly closer examination to determine their authors. The unbound materials would probably be best organized by separating the travel ephemera from the other papers and filing them separately by geographical location of subject. The other papers would be best separated by the primary individual to whom the papers refer or belong (e.g. Matilda McAllister) and then organizing by document type (e.g. correspondence, income tax return, et al.). Most of the items are in good condition. A few of the diaries and other books have some wear on the covers, but overall they are almost completely intact.
