Abstract	<p>The Warshauer-McClure Sheep company was established by Frederick Warshauer, a German immigrant. The company named changed on February 2nd, 1928, to the Warshauer Sheep and Wool Company and was one of the largest sheep and wool companies throughout the San Luis Valley. The company was located in Antonito, Colorado, where the San Luis and Rio Grande railroad merged with the Cumbres and Toltec railroad, which created a lot of business. This collection consists of four record books of the Warshauer Sheep and Wool Company and one separate account of Ella Warshauer.</p>
