At the time of its listing on July 10, 2003, it was believed that the Jamestown Town Hall, at 118 Main Street in Jamestown, stood within Lot 27 and the north 140' of Lot 28, Block 10, Jamestown, Boulder County, Colorado. A recent resurvey of the property determined that parts of the building extend into the adjacent property and into the right of way for Main Street. The revised boundary description below reflects the actual location of the building and the land included in the National Register listing. The new boundary includes a new property owner who was provided an opportunity to consent to the expanded boundary. No new resources are being added to the listing.

#### **Verbal Boundary Description**

Lot 27 and the North 140' of Lot 28, Block 10, Jamestown, Boulder County, Colorado, plus encroachments onto the south 10' of Lot 28 and Lot 29 and the Main Street right of way, plus a 5' wide strip around the encroachments.

The attached map labeled "National Register Listing Boundary" shows the approximate location of the above verbal description.
